The Lake County A's would like to invite you to our 2019 25TH Spring Opener.

We have a weekend of fun planned for our Model A friends. The dates of this year's event are May 3rd, 4<sup>th</sup>, 5th 2019. The host hotel for the 25th Spring Opener is The Lodge at Blue Lakes. The Lodge at Blue Lakes is located 7 miles west of Upper Lake on HY20.

Registration will be at The Lodge at Blue Lakes on Friday, May 3rd, from 12:00p.m.-4:00p.m. Raffle prizes will be on display and raffle tickets will be available.

The Lodge will offer a Friday night buffet pasta dinner at a cost of \$20.00 per person in the dining room from 5:45p.m.-6:45p.m. The Lodge's "no host full bar" will remain open until 9:00p.m.

Registration for late arrivals will be available on Saturday morning, May 4th, at the Lodge from 7:00a.m.-8:30a.m.

The line up for our Saturday Tour will be in the parking lot of Upper Lake Park located on Highway 20 in Upper Lake at 8:40a.m.. Please arrive with a full tank of gas. The Tour will depart Upper Lake Park at 9:00a.m.

We will proceed east on HY 20 to Highway 53, and then south to Clearlake for a rest stop. We will depart Clearlake and retrace the First Spring Opener Tour route.

We will retrace the First Spring Opener Tour route by proceeding south on Highway 53 from Clearlake to Highway 29, to Seigler Canyon Road, to Highway 175, to Red Hills Road, to Soda Bay Road, to Fairway Drive, and on to the Riviera for lunch.

The first Spring Opener tour lunch was held at the Konocti Harbor Inn. Unfortunately, The Konocti Harbor Inn closed some time ago. However, the Riviera Restaurant, Golf & Country club is a stone's throw away from the old Konocti Harbor Inn.

You will enjoy a Taco Bar Lunch with all of the fixings at the Riviera Restaurant, Golf & Country Club. You will see the most expansive and beautiful view of Clearlake from the restaurant. Your lunch is included in your registration fee. After lunch, you will be returning on your own to your hotel/motel.

The Saturday night banquet will be held at The Lodge at Blue Lakes. It is also included in your registration fee. A "No Host Full Bar" Social Hour will start at 4:30 p.m. and dinner will be served at 6:00p.m. Our entertainment, raffle, and auction will be held around 7:00p.m.

Sunday morning, May 5th, breakfast will be on your own.
